Rockland County Volunteer Firefighters' Association

Mission statement: The object of this Association is the advancement of the interests of the volunteer firefighters, fire companies and fire service, promoting and strengthening the bonds of unity, which should properly exist among the various fire departments and companies throughout Rockland County and to render assistance, encouragement, education and safety, and in general, everything that would tend to enhance the efficiency of volunteer firefighters and further their cause.

Who can join? All active firefighters holding membership in a fire company or fire dept. within Rockland County may be elected to membership in this Association, providing that they are a minimum of 16 years of age and a member in good standing in their respective organization at the time application is made for membership in this Association.

Annual dues and when due: \$10 by the date of the annual convention of each year **Meetings:** second Friday of the month at various firehouses throughout the county, starting at 7:30 p.m. If the meeting should fall on a religious holiday, the meeting shall be held on the third Friday of the month. Start time is 7:30 p.m.

Type of meeting programs: educational and informational, to keep members up-to-date on firefighting operations and legislation that pertains to them, with an emphasis on firefighter safety and wellbeing. We also celebrate the heritage that has brought the organization thus far and past leadership. Dinner is served to the member after each meeting, supplied by the host fire company.

Membership benefits: The Association annually sponsors two \$1,500 scholarships for high school graduating children and grandchildren of RCVFA members. There is also a death benefit as part of Association membership. The RCVFA annually runs the county firefighter convention and parade jointly with the host company and provides monetary assistance to the host company.

The Association sponsors an annual Day at the Home for the state Firefighters Home in Hudson, N.Y. It provides bus transportation and refreshments for the day trip. The Association and member departments/companies collect funds and make a presentation to the Home that day. The Association annually recognizes and celebrates length of service for all Rockland firefighters with 50 or more years of service as well as companies with significant anniversaries. The Association publishes an informative, free newsletter monthly known as The Trumpet and distributes it to all volunteer fire companies.

The Association also provides a free equipment link on its website for the Rockland County Fire Chiefs' Association where departments can inventory and swap/sell or give away used equipment within the county.

The RCVFA sponsors the annual Firefighter of the Year and Unit Citation awards program as well as the William J. Herman Memorial Training Award. It sponsors the Rockland County Fire Prevention Committee. We provide informational and educational programs at our monthly meetings and look forward to assisting in sponsoring any future seminars as needed by any other county fire association.

Meetings: the third Wednesday of the month, **except June and December**, starting at 7:30 p.m. at various firehouses around the county.



ANDREW A. FREDERICKS MEMORIAL SCHOLARSHIP

Andrew A. Fredericks was a firefighter in FDNY's Squad 18 in Manhattan, and was one of the 343 firefighters who lost his life while rescuing others from the World Trade Center Towers on September 11, 2001. Andy held a BA in Political Science, a BS in Public Safety & Fire Science, a MA in Fire Protection Management and, in addition to the FDNY, was at times a member of the Suffern, NY and Alexandria, VA Fire Departments. With a fire service career of over 21 years, Andy Fredericks was always eager to share his knowledge and experience with others. Andy touched lives across the country through his work as a fire instructor at the Rockland County Fire Training Center, the NYS Academy of Fire Science, the NYS Association of Fire Chiefs, and the Illinois Fire Service Institute. Andy was also an adjunct professor at Rockland Community College, an adjunct lecturer at John Jay College of Criminal Justice, and a member of the Editorial Advisory Board of Fire Engineering and the FDIC Educational Advisory Board.

In memory of Andy's life and work, two scholarships, each in the amount of \$1500 will be awarded. The scholarships are sponsored by the Rockland County Fire Instructor's Association (RCFIA), the Sonora, CA Area Foundation, and the Elmsford, NY Fire Department.

It simulates situations that are experienced in the fire services of the United States. Our Drills consist of various training scenarios ranging from first aid to structure fires.

Who can join? any Rockland County resident between 14 and 21 years of age.

Annual dues: membership fee of \$65, dues thereafter is \$35, you will need a recent medical physical and when you sign up, you must also bring a parent or guardian.

Meetings: the Post generally meets every other Sunday from 1800 to 2100 hours (6:00 PM to 9:00 PM) at the Rockland County Fire Training Center. Members are expected to maintain reasonable attendance.
